European Commission aiming to reform GDPR enforcement rules in cross-border cases

The European Commission has published an initiative to specify the procedural rules that accompany GDPR enforcement. Currently in its feedback period, which opened on 24 February and will close on 24 March 2023, the Commission aims to harmonise procedural rules specifically in cross-border cases. It remains to be seen however to what extent the reformed rules will streamline enforcement actions in the EU.
