# Upgrades on EU company law with an emphasis on digitalisation expected

#### The French Ministry of Justice starts work on the confidentiality of in-house lawyers' advice

Original interview conducted in French by Ondine Delaunay - The confidentiality of legal advice given by in-house counsel as part of their employment has long been a highly contested discussion in EU jurisprudence and within several EU Member States.
