HAN KOOY BECOMES ECLA'S 6th PRESIDENT

During the ECLA Board meeting in Manchester Han Kooy was elected as ECLA's sixth president. No other candidates had expressed interest so it was not a surprise election. More important is that Han experienced full support of the Board Members and was elected unanimously. Many Board members took the opportunity to express their confidence in Han Kooy and their feeling that the presidency is in good hands. Han joined the ECLA Board as the representative of the Dutch Genootschap van Bedrijfsjuristen during the Board meeting in Stockholm and immediately volunteered to work on the amendment of the (25 year old) bylaws. Han also closely worked with ECLA's former president on the AKZO Nobel case intervention by attending the court session in Luxembourg and in participating in the preparation meetings at ECLA's law firm Cleary Gottlieb Steen & Hamilton in Brussels. Han also substituted Paul de Jonge during the annual meeting of the Czech Association and gave a briefing on the AKZO Nobel case. Despite his short tenure on the Board, Han is well prepared to take this new position. In his capacity of NGB Board Member Han has closely followed developments in ECLA during the last eight years.

Han is senior counsel at Shell Oil Products in The Hague and gained international experience through assignments in Italy and Curacao. In his current position Han is responsible for the legal aspects of Shell's refineries worldwide.

In a first reaction after his election Han said: "In this new function I will focus on expansion of the membership professionalization of ECLA all for the benefit of our members. I look forward to closely work with the national organizations and hope to visit all 22 of them during my presidency".

Han Kooy's presidency took effect after the Manchester Board Meeting.

NORWAY APPOINTS NEW BOARD MEMBER OF ECLA



ECLA ENDORSES THE FIRST CENTRAL EASTERN

EUROPEAN IN-HOUSE COUNSEL SURVEY

ECLA endorses the first survey in Central & Eastern Europe (CEE) on how in-house counsel select and retain external counsel. LexisNexis Martindale Hubbell (International) commissionned this research which is the first of its kind to focus on this region in Europe. ECLA's member associations in the region are taking part in the survey which should be published in the summer of 2008. Anyone who participated in the survey will receive a free copy of the report.

ECLA REPRESENTED AT THE FOURTH ANNUAL CPR EUROPEAN CONGRESS ON BUSINESS DISPUTE MANAGEMENT

The International Institute for Conflict Prevention and Resolution-CPR of New York held its fourth annual European congress on Business Dispute Management on May 14-16 in Vienna. ECLA co-sponsored the event in return for a 25% discount on the fee for its members. Francesco Benigni moderated a very lively panel on "Real-Time" dispute management processes.

ECLA REPRESENTED AT THE EIGHTH ANNUAL CONFERENCE ON ANTITRUST

ECLA sponsored the VIII edition of the Treviso, Italy, conference on "Antitrust between EC law and national law" on 22-23 May. The members of ECLA received a discount of 20% off the fee. ECLA ENDORSES SEMINAR ON NEGOTIATION

ECLA sponsored "Negotiation at its best" a training course organised by ADRCenter and Hamline University School of Law in Saint Paul, Minnesota. The two-day session was held in Rome on 27-28 May and the members of ECLA received a 25% discount off the official fee. ECLA ENDORSES OXFORD UNIVERSITY SURVEY ON CIVIL JUSTICE SYSTEMS IN EUROPE AND IS REPRESENTED AT THE PRESENTATION CONFERENCE IN OXFORD

ECLA and its member associations participated in a survey organised by the University of Oxford Faculty of Law, on "Civil Justice Systems in Europe: Implications for Choice of Forum and Choice of Contract Law". The results of the survey, which should be published soon, were presented at the conference on 14 March. The conference was held at St. Anne College in Oxford. Sandra Mori from Italian member association gave a very interesting presentation entitled "Implications for European Legal Policy: A Business Perspective".

ECLA commissioned two studies for AKZO Nobel intervention

In preparation for ECLA's intervention in the AKZO Nobel case which is now pending before the EU Court of Appeal in Luxembourg, ECLA has commissioned two studies. Since the AKZO case was triggered by correspondence by a Dutch in-house counsel who is a member of the Dutch NGB (In house counsel association) and of the Dutch bar, certain aspects of Dutch law needed additional in depth study.

Human Rights aspects

Certain aspects of Human Rights are of importance in this case, both in the formal as in material sense. To what extent can the freedom to select counsel play a role here and how can we be best prepared to make this case ready for an appeal to the European Court for Human Rights in Strasbourg? Art 6 3c of the Treaty on Human Rights provides that everyone has the right to be defended by a counsel of his own choice. Preventing this by not granting legal privilege to in-house counsel makes it a matter to be litigated before the European Court of Human Rights. However, the road to this court is only open if all other means to litigate it have been exhausted. Therefore, it is of importance that in the AKZO Nobel case, this aspect is also addressed. If the court unfavourably decides on this, we have exhausted all our legal means and we will be in a position to submit the legal privilege issue to this court.









We have looked for the best lawyers in this field in Europe. Some were not available and some could not make available the necessary resources. We are glad that we could retain Professor Barkuysen of Leyden nUniversity who has an excellent track record in this field. He used Human Rights defenses in cases regarding the allocation of broadcast bands before the Luxembourg courts. In writing his contribution, he as assisted by X and Y of Kennedy Van der Laan, an Amsterdam based law firm with an established reputation in this field. The contribution has been incorporated in the AKZO intervention and can be recognized by the intensity of notes in the text.

IMPLEMENTATION OF IUS LABORIS SPONSORSHIP AGREEMENT

lus Laboris and ECLA entered their second year of cooperation. Francesco Benigni met with Carolyn Knox, the new executive director, at the IUS Laboris headquarters in Brussels. They discussed how to better implement the relationship between the two organisations for the benefit of the member associations of ECLA. Ius Laboris is an alliance of law firms with expertise in labour, employment, employee benefits, immigration and pension law, which has 46 law firms in 44 countries around the world with a strong presence in the EU. The cooperation between ECLA and lus Laboris will include regular legal updates on the changing interpretation of EU directives related to employment for ECLA members, collaboration between ECLA's member associations and local lus Laboris firms which could include conferences and local activities.
