I look forward to catching up with many of you in Boston, and to making many more new acquaintances who share my passion for the law and all it can do to serve the world's community.

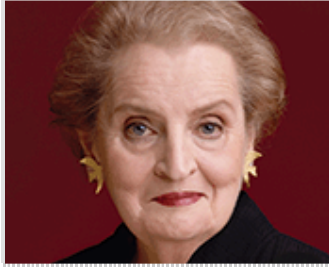

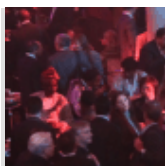
